- Other extraordinary volunteerism and/or service in governmental affairs, such as:
  - Serving as an SLC (Illinois REALTORS® State Legislative Contact), FPC (National Association of REALTORS® Federal Political Coordinator) or comparable political advocacy liaison role.
  - Meetings with legislators, regulators or officials
  - Testifying on legislative matters of importance to Chicago Association of REALTORS®, Illinois REALTORS® and/or National Association of REALTORS®
  - Serving on a Public Policy Committee at the Chicago Association of REALTORS®, Illinois REALTORS® and/or National Association of REALTORS®
  - Educating REALTORS® and/or the public on advocacy matters, private property rights, housing and economic development issues.
